News from Child Care Aware of WA Scholarships

Fall is a great time of year to get prepared for a great academic year. Make sure your education information in MERIT is current, double check to be sure all of your scholarship forms are submitted and start researching national scholarships and other sources of higher education funding, including any scholarships offered at your college/university.

It's also time to fill out the Free Application for Federal Student Aid (FAFSA) for the 2020-21 academic year. Forms for next year were made available Oct. 1. For full information, visit <https://studentaid.ed.gov/sa/fafsa>.

By now you have probably heard a lot about the Washington educational requirements for child care licensing that came out with the Aug. 1 WACs. There are three pathways providers can choose from to meet the requirements in the next five years. 
"I advocate because I know that the work we do as providers is important...I believe we have the power to make changes when we join and express our needs and concerns at the state level."

April Nicholas used to work three part-time jobs while raising two sons, so she knows how hard it can be to go back to school. But, she said "I knew I needed an education so that we could actually live...There is always a way if you are determined to go and know what you want."

Now she's the lead teacher at Lower Columbia College Head Start and is working toward her BA in Children's Studies at Eastern Washington University via their online program. Being able to attend school online allows her to continue to serve children in her community while she's in school.



April credits her scholarship from CCA of WA Scholarships with making it possible for her to be a lead teacher, because she could not attend the university without the support the scholarship provides, and Head Start requires teachers to have degrees.
