BUT MANY CHILD CARE PROGRAMS ARE CLOSING OR ARE ON THE VERGE OF CLOSING, NOT BECAUSE OF EXPOSURE TO THE VIRUS, BUT BECAUSE THEY CANNOT GET THE SUPPLIES THEY NEED TO SAFELY OPERATE THEIR SMALL BUSINESSES. THESE SUPPLIES INCLUDE CLEANING AND HYGIENE PRODUCTS, USDA COMPLIANT FOOD AND DAIRY PRODUCTS. THE MOST URGENTLY NEEDED ITEMS ARE HAND SOAP, TOILET PAPER, BLEACH AND PAPER TOWELS. MANY CHILD CARE OWNERS SHOP AT THEIR LOCAL MARKETS, WHICH ARE OUT OF MANY OF THESE SUPPLIES. WE LOOKED FOR AND CONTRACTED WITH COMMERCIAL SUPPLIERS FOR BULK ORDERS OF SUPPLIES AND ORGANIZED DISTRIBUTION ACROSS THE STATE. WE SOUGHT INDIVIDUAL, CORPORATE, GOVERNMENT, AND FOUNDATION SUPPORT TO GET AS MUCH AS POSSIBLE OUT TO CHILD CARE PROGRAMS.
